CONSENT GIVEN

On behalf of the individual identified in this Consent Form (the **Individual**), the person or persons signing this Consent Form (the **Signatory**)* grant consent to the Royal National Agricultural and Industrial Association of Queensland (RNA) to use, record and disclose the Individual's:

- Photographic image and no other identifying information other than the school name

Note: If the Individual is under 18 years of age, the Signatory must be a parent or guardian of the Individual. The Individual must also sign if he or she is under 18 **and able to give and understand the consent. If the Individual is 18 or older, the Signatory and the Individual will be the same person.*

PURPOSE

This consent applies to any use, recording or disclosure of the Individual's personal information, photographic image or Individual work, in connection with the RNA for the following purposes:

 - use by the media in relation to the Individual's participation in school activities

DURATION

This consent will continue:

- for an Individual under 18 years of age, until the Individual turns 18; or
- until the Individual revokes consent by writing to the RNA;

and where more than one of these events may apply, until the first event occurs.

Despite the above, if, at the time such an event occurs and the RNA is using the Individual's personal information, photographic image or individual work, or the RNA has entered into contractual obligations in relation to that material, the consent will continue in relation to that material until the use by the RNA is complete or until the contractual obligations come to an end.

UNDERSTANDINGS

- 'Use' includes:
 - to create, make copies of, reproduce or retain in any form, including by camera, video, digital recorder, webcam, closed circuit television, mobile phone or any other device; and
 - to distribute, publish or communicate in any form, including in newsletters and other print media, television and the internet,in whole or in part, and to permit other persons to do so.
 - The RNA will not pay the Signatory or the Individual for giving this consent or for the use of the Individual's personal information, photographic image or Individual work.
 - This Consent Form revokes and replaces all previous consent forms in relation to the Individual.
 - Nothing in this Consent Form limits the rights that the RNA reserve in relation to the use of the Individual's personal information, photographic image, Individual work or other intellectual property under any other law.
 - This consent extends to the RNA:
 - disclosing the Individual's personal information, photographic image and Individual work to the RNA's agents, contractors and volunteers for the purpose of performing services for the RNA; and
 - permitting those persons to use, record and disclose such material to the same extent as the RNA are

INFORMATION

What is this consent for?

This Consent Form authorises the RNA to use the Individual's personal information, photographic image and copyright material, together with information about the Individual's participation in RNA initiatives, for any use by the RNA associated with the purposes identified in the **Purpose Section** of this Consent Form. The consent covers the entire or partial use of the Individual's personal information, photographic image and copyright material in conjunction with other words and images.

For example, the Individual's personal information, photographic image and copyright material may appear in RNA promotional material as well as school or TAFE newsletters, magazines, websites and other school, TAFE, Education Queensland publications, as well as in television advertising, videos, brochures, forms, public relations displays, annual reports, press advertising, internal documents such as manuals, websites, certificates and strategic plans, and posters and other promotional material.

What is copyright material?

An Individual's copyright material may include written work (e.g. stories and poems), paintings, pictures, drawings, designs, photographs, videos, films, music, performance, recordings, computer programs, websites, sculptures, fashion, metal- or wood-works made by them or to which they contributed. In the case of students, it includes, but is not limited to, work that they create in the course of their studies during the time they are enrolled at a school. These materials may form part of their academic assessment or be part of their studies generally and may attract copyright.

The RNA understands that students and volunteers generally own the intellectual property rights in the material they create and that this Consent Form is not meant to transfer the Individual's ownership of the intellectual property in their copyright material.

What is a photographic image?

An individual's photographic image includes photographs of the individual and educational activities carried out by the individual.

What is personal information?

Personal information includes information or opinions, whether true or not, about an individual whose identity is apparent or can reasonably be ascertained from the information or opinion. This includes the Individual's name, recording or image. It will not include the Individual's educational information such as the Individual's assessment and results, and health information and court orders provided to Education Queensland, where such information may enable the Individual to be identified.

Why is a Schedule used?

A Schedule may be attached to this Consent Form describing a specific use of the Individual's copyright material, photographic image or personal information, either because the use falls outside the purposes listed in the **Purpose Section** or to confirm the consent in this form.

What happens to the Consent Form once it is completed and signed?

The Consent Form is retained by the RNA and it will be placed on the project file. The Individual or Signatory may request a copy of the signed form by contacting the RNA.

What if I give my consent and later change my mind?

This consent will be in effect for the period described in the **Duration Section** of the Consent Form. The consent can be modified or withdrawn at any time by contacting the RNA. However, any changes will apply only from the date that the RNA receives any consent withdrawal. Any existing material will not be withdrawn from use if the RNA is currently using the material or where the RNA has entered into contractual obligations in relation to this material. In such cases the withdrawal will be effective after the RNA's use is complete or after the contractual obligations come to an end.

Privacy

Personal information will be stored securely. The RNA will only disclose the Individual's personal information in accordance with your consent, except where authorised or required by law. If you wish to access or correct any of the personal information on this form or discuss how it has been dealt with, or if you have a concern or complaint about the way the Individual's personal information has been collected, used, stored or disclosed, please contact the RNA.
