Our competitions are the backbone of the Royal Queensland Show (Ekka), bringing the city and country together each year to showcase the best of the best.

In 2023 the 144th Ekka was the most attended Show since 2019, since before the Covid-19 pandemic. Queensland's biggest and most loved event was an incredible success, attracting around 400,000 people.

We were delighted to once again reward and recognise our exhibitors across 54 competition sections. The RNA received over 20,000 competition entries, a 12% increase on 2022, which is also back to pre-pandemic levels.

More than 4,400 exhibitors travelled from across the country for their chance to win a coveted blue ribbon when the Ekka awards and celebrates the best of the best.

The entries included 4,257 prized animals, 1,231 cakes and condiments and 634 works by Queensland students.

Our competitors were able to share in a total prize pool of almost \$680,000 – a 10% increase on last year.

In 2023 we hosted 10 international judges, ensuring exhibits were judged by some of the world's most highly experienced and respected individuals.

In 2024, the nine-day Show will be held from Saturday 10 August to Sunday 18 August, running over two full weekends.

Since 1875, the RNA has been dedicated to championing agriculture and is honoured to stage Queensland's largest event on behalf of the community each year.

We look forward to continuing this wonderful legacy for future generations of exhibitors and patrons to enjoy.

GENERAL OPERATING HOURS OF AGRICULTURAL HALL

The Agricultural Hall will be open between 9.00am and 6.00pm daily during the Royal Queensland Show.

YOUTH IN AGRICULTURE REGULATIONS

1. The By-Laws together with these Regulations will govern the competition.
2. Exhibitors in the Agricultural Hall are advised that in accordance with RNA policy no stickers are to be handed out during the Show. The handing out of balloons is not permitted unless written approval is obtained from RNA Management. Exhibitors must check that their displays comply with copyright regulations.
3. The licensee/exhibitor shall not conduct or operate any gambling game(s) or games of chance or dispose of any article by lot or chance or sell any raffle tickets of any nature whatsoever unless these activities have been approved by RNA Management. Exhibitors and competitors wishing to conduct a competition, including a give-away promotion or guessing competition, must ensure they comply with the relevant legislation.
4. The Organiser of each exhibit shall be a group member or a supervisor of a group. Fruit and/or vegetables may be drawn from any district for those youth groups selecting to undertake Class 1, 2 or 3.
5. Entries in the Youth District (Class 1 or 2) and Youth Fruit and Vegetable (Class 3) Competition shall be limited to six (6) in total or otherwise determined by the RNA Councillor in charge.
6. Open to youth groups, church youth groups, or schools or colleges. Exhibits must be designed and constructed by 13-25 year olds. Adult's assistance may be provided with the design of exhibit and construction of the back wall only. All construction on the exhibit floor (unless done by RNA carpenters) and all produce on display must be placed on the exhibit by the youth members.
7. Groups are permitted to display one A3 sign on the front of their display acknowledging supporters that have assisted in their display. The sign can list up to five names (excluding all logos).
8. If possible, groups are requested to provide continuous supervision of exhibits. Competing groups may share this responsibility.
9. Commercially available citrus wax is the only form of polish/spray permitted to be used on produce for sale at the conclusion of the show.

ORGANISING ALLOWANCE

1. YOUTH DISTRICT EXHIBITS (Class 1 or 2)
Upon written application to the Entries Department Royal National Association, a sum of money for organizing and expense purposes, including meals, will be paid to each competing exhibit in addition to prize money.
This will be assessed on a one-way road distance from Brisbane to the place or town where the group exhibiting has its regular meetings. Allowances are calculated as follows:

	Class 1 & 2 - Section 1 & 2
Up to 80 km	\$1,600
Over 80 km up to 240 km	\$1,800

Groups over 240 kms from Brisbane should contact the RNA about special arrangements.

2. YOUTH FRUIT AND VEGETABLE (Class 3)
The sum of \$2,700 for organizing and expense purposes, including meals, (in addition to Prize Money) will be paid to each competing group. At the discretion of the RNA and upon written application to the Entries Department, early payment of the organizing allowance may be made to any competing group if required to complete their display.

Any group which is in excess of 160 kilometers from Brisbane will be paid an additional \$200 as a travelling allowance.

3. All claims for organizing allowance must be accompanied by completed documentation to the value of the amount received from the RNA. Valid tax receipts/tax invoices must be in the hands of the RNA Competitions Coordinator by 30 August of the year they relate to. No payments can be made for expenses received after that date. In the event of a group failing to compete, the allowance received must be returned to the Royal National Association within seven (7) business days.

PRODUCE COLLECTION AREA for Class 1, 2, or 3.

- a) No limit shall be defined for the area in which Groups may obtain the required produce, but the Organizer of each exhibit will be required to certify that all exhibits entered for judging under Section 2 (Two) have been produced, grown, manufactured, purchased, or obtained by members of the competing Group or Groups.

CONSTRUCTION

1. All construction on the exhibit floor (unless done by RNA carpenters) and all produce on display must be prepared and placed on the exhibit by the youth members (13-25 year olds). Advice and support with tools may be given to group members when required by adults associated with the group.

Exhibitors are not permitted to use spray paints / spray cans in the venue at any time.

Compliance with this and other schedule regulations prior to commencement of judging is worth 50 points.

2. Plans of the allotted space are available on application. The Group Organizer must forward plans of the exhibit by the due date to:

The Royal National Association will arrange for the completion of the stand in accordance with the plan submitted.

Plans should give full details of all construction required and upon receipt the Association will proceed to erect stands according to these plans. Any requests for 3 phase power must be submitted with the plans by the due date.

The RNA reserves the right to return plans to exhibitors for alteration if those plans are deemed by the Ground Superintendent/carpenters to be too expensive or complex to build. It is not expected that any display will take longer than one day to construct.

The RNA will not be responsible for any further alterations or additions to the stand after they have been erected, and such alterations and additions must be carried out by the Groups concerned, at their own expense.

An inspection of the stand may be made by the Youth Group Organizer, when advised that the work has been completed.

RNA tradesmen will not be available after the exhibit has been completed and inspected. Groups are requested to keep the same basic design for a period of at least 2 years. Minor modifications will be permitted.

3. Details relative to lighting and power points are to be shown on the plan when submitted. Upon approval and once installed the RNA will not be responsible for the supply of additional lighting or power requirements, and additions or alterations to lighting or power will not be made without prior consent of the RNA Electricians. All such work must be carried out by a fully qualified electrician.
4. All groups must depart the Agricultural Hall by 10.00pm each night.
5. Groups are not permitted to have sound as part of their exhibit.
6. RNA tables will be available to groups.

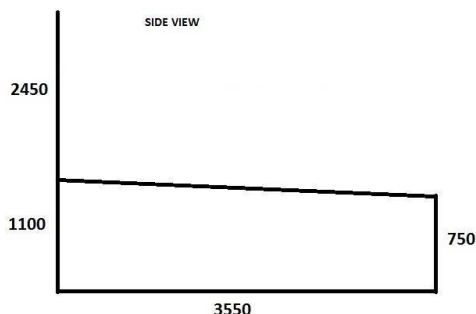
SPECIAL REGULATIONS

1. Exhibitors are to submit a detailed list of relevant workers or persons required to receive entry during show no later than Monday 22 July 2024 to the RNA Coordinator.
2. Groups are required to maintain the standard of exhibits during the period of the Exhibition. Quality of produce must be such that it should last for the duration of the show, however perishing items where necessary can be replaced with similar items of reasonable quality to maintain the standard of the exhibit.
3. Selling time to commence from 3:00pm Sunday 18 August 2024, or according to Show crowds and/or weather conditions as advised by the RNA Councillor. Please be advised that exhibitors are permitted to pack down stands after 6:00pm and vehicle access to grounds will commence after 10:00pm. Vehicle Permits apply; please see front cover for further information.

TICKETING

1. All ticketing, labelling, or wording of any kind on the Exhibit should be large enough to be clearly readable at a distance of 5 metres.
2. Each individual item need not be labelled as such, but intelligent use of captions, labels, and signs to indicate the connection between produce displayed and the actual theme of the Exhibit will be beneficial and will add to overall appeal of the display.
3. Where an item cannot be readily identified by a Judge, i.e., timbers, cakes, jams, jellies, etc., a small label at the base is sufficient.
4. Unusual items not easily identifiable, as well as grains and fodders, etc. should be labelled, if possible, for the convenience of the public. Ticketing need not be the work of Group Members.

JUDGING

1. All construction work and placing of materials must be completed by 12:00pm Friday 9 August 2024 so that walkways are clear ready for presentation the next day. Stewards will check each exhibit after this time for compliance with schedule concerning quantities on your stand.
2. No Group will be allowed to arrange or add to their exhibits after this time. Judging shall not commence until the delegate in charge of the Exhibits has been notified. During the Effective Arrangement judging no competitors or associates may enter the exhibit designated area. All other judging will commence as shown unless advised to the contrary by the Stewards.
3. All items displayed on the exhibits shall remain on the exhibits for the duration of the show. Quality of produce must be such that it should last for the duration of the show, however perishing items where necessary can be replaced during show with similar quality produce.
4. Only officials and exhibitors may enter the judging area whilst judging is proceeding.
5. At least one member shall be appointed by each Group exhibiting to be in attendance during the full period of judging and to assist the Judges and Stewards whenever necessary. If a group cannot be present at the nominated judging time, they should arrange with a Steward to present their produce to the judge.

EFFECTIVE ARRANGEMENT

YOUTH DISTRICT EXHIBITS Class (1 & 2)/ YOUTH FRUIT & VEGETABLES (Class 3)

SCALE OF POINTS USED IN THE JUDGING OF EXHIBITS

CLASS 1, 2 & 3 Section 1

- a) Public Appeal Points will be awarded for use of lighting, design, colour, movement and public appeal.
Maximum 50 points
- b) Display
Effective use of theme and design.
Maximum 50 points
- c) Effective Use of Products
Diversity, quality of display, arrangement, and quality of items.
Maximum 50 points
- d) General Finish and Neatness
Judges will consider the overall standard and finish of the exhibit. Including presentation of primary produce and including display signage. ALL Grains on the floor of the exhibit must be presented in its natural state. Points will be discounted for failure to comply. Washing and cleaning of naturally dirty products e.g., pumpkins, melons etc. are acceptable.
Maximum 50 points
- e) Compliance with construction and other schedule regulations prior to judging.
- i. Correct and current tagging of all electrical appliances 5 points
- ii. Compliance with all regulations in the schedule 10 points
- iii. Plans/requests submitted by deadlines 5 points
- iv. Work and materials are to be kept in own designated areas at all times 10 points
- v. Safe working conditions maintained during set up period 10 points
- vi. Fences to be returned to their correct places and the display area is clear of all rubbish and left tidy by 11:00am Friday 9 August 2024. 10 points
- Maximum 50 points
- Total Maximum (Section 1) 250 points
- f) NOTE: Judges of this section also allocate marks for Youth District Exhibits Class 2 only, entered into Commercial Timbers in Section 2. Sub Section (vii) (e). As per schedule, 20 points are allocated which are added to other points awarded for Commercial Timber judging.

YOUTH DISTRICT EXHIBITS

Class 1- Youth District Exhibits

Section 1

Youth District Exhibits (Class 1) can use a range of produce and materials to decorate their produce stand but are not being judged on individual quantities of materials presented. Ideas of types of produce (fruit/vegetables/ grains and fleeces etc.) can be gained by reading Sub Sections in Section 2 from YOUTH EXHIBITS (Class 2) below.

Class 2- Youth District Exhibits- Section 1 & 2

Youth District Exhibits (Class 2) complete Section 1 and 2 of this competition.

Section 2

Groups must supply a list of subsections being entered to the Competition Officer, no later than Monday 1 July 2024. This includes:

- (i) Grains;
- (ii) Fodders;
- (iii) Fresh Fruits;
- (iv) Culinary Arts;
- (v) Vegetables;
- (vi) Other Agricultural Produce;
- (vii) Commercial Timbers;
- (viii) Other Produce.

FOUR shall be nominated for judging of quality.

Details of the Sub- sections nominated for judging must be received not later than Monday 1 July 2024. A maximum of 60 points may be obtained for each Sub-Section so nominated.

Total Maximum (Section 2) 240 points

Aggregate Maximum (Section 1 and 2) 490 points

The following conditions for judging of quality apply to the eight Sub-Sections in Class 2. (Larger quantities of any item in these Sub-Sections may be exhibited for display purposes. The quantities stipulated below refer to items for judging of quality only.)

NB. Where sheaves, grain, hay and other produce cannot be conveniently inspected by the Judge a sufficient portion of each exhibit must be set aside in a position where it can be readily examined. Minimum sample portions are as follows;

Grains	1 kg
Fruit	3 kg
Root Crops	2 kg
Any other Veggies	2 kg
Nuts	500 g + 100 (no shell)
Fibre	500 g
Other Products	as stipulated in Sub Section (viii)
Oil Seed	500 g

Any exhibit failing to meet the minimum sample requirements for any sub-section will not be awarded points in that category.

Sub-Section (i) GRAINS

(Maximum 60 points)

At least 1kg each of any three of the following: (3 x 20 points per type)

- Wheat,
- Oats,
- Barley,
- Sorghum,
- Triticale,
- Maize,
- Canary,
- White French Millet,
- Grey Striped Sunflower
- Red Panicum

Grains on the back wall or seeded arrangements are not included as part of the 1kg of grain specified for judging. Seeds treated with seed dressing or coatings are not eligible for entry. All seeds should be free of any chemicals with the exception of weevil fumigant. The display of grain for judging on exhibit floor must be all grain and not topped.

Sub-Section (ii) FODDERS

(Maximum 60 points)

One sample from any two of groups A, B or C.

Your requirements for this section are:

- A. HAY (30 points) half a bale of minimum dimensions 430mm x 480mm x 340mm.
 - B. CHAFF (30 points) minimum of 9 liter (half a tomato box or 1 x 9 liter bucket)
 - C. Either (i) Raw Hammermill Products or (ii), Stockmeal Products. (Total 30 points)
- (i) **RAW HAMMERMILL PRODUCTS** (1 kg each or a total of 3kg if in combination) to be comprised of any THREE grains either SEPERATELY or in COMBINATION displayed in EITHER the fine OR the coarse state. These do not include chicken starter, laying mash/pellets or any commercially manufactured feed that has additional vitamins, supplements or minerals added.
- (ii) **STOCKMEAL PRODUCTS** (1kg each). To be comprised of any three stock meal products. Stock meals in pelleted form are not acceptable.

Raw Hammermill/Stockmeal products must be labelled for judging clearly showing the type of grain or fodder used – particularly in the case of mixtures. Labels must also indicate the purpose for which the product is intended (e.g. Horses, cattle, sheep, pigs, poultry, goats, camels etc.)

Sub-Section (iii) FRESH FRUITS

(Maximum 60 points)

Not less than 6kg of one of the Sub-Sections (a), (b), (c), (d) – (30 points for any 2 varieties), or (e).

- a) Stone and/or Pome Fruit - two varieties (3kg of each variety)
 - b) Citrus - two varieties (3kg of each variety)
 - c) Tropical Fruit - two varieties (3kg of each variety)
 - d) Any other fruits - two varieties (Rockmelons, honeydew melons, berries, avocados etc.) (3kg of each variety)
- OR**
- e) One variety (2kg) from THREE of the sub sections (a), (b), (c) or (d). (20 points each variety)

Sub-Section (iv) CULINARY ARTS

(Maximum 60 points)

Three of the following (20 points for each type)

No commercially produced products are to be entered for judging.

- (a) Decorated Cake – one 15cm (6 inch) minimum cake e.g., Birthday, Anniversary, or Christmas.
- (b) Plain Scones – 7 to be exhibited.
- (c) Muffins – 6 to be exhibited.
- (d) Homemade Chocolates – 10 plain or filled.
- (e) Homemade Biscuits – 2 varieties – 4 of each variety
- (f) Boiled Fruit Cake – 15cm (6 inch) minimum cake

All to be cut by judge with the exception of the decorated cake.

- (g) Jams - Two 500g bottles (2 distinct varieties required, one bottle of each)
- (h) Marmalades - two 500g bottles (2 distinct varieties required, one bottle of each)
- (i) Sauces - two 300ml bottles (2 distinct varieties required, one bottle of each)
- (j) Chutneys - two 500g bottles (2 distinct varieties required, one bottle of each)
- (k) Pickles - two 500g bottles (2 distinct varieties required, one bottle of each)

All items to be correctly named with small labels to allow identification by the Judge. Jams, jellies, marmalades, sauces, chutneys and pickles should be exhibited in sealed jars and will be opened by the Judge.

Sub-Section (v) VEGETABLES

(Maximum 60 points)

Enter any TWO of Sub-Section (a), (b) or (c).

- (a) Pumpkins - three samples of any two of the following pumpkins – Jarrahdale, Qld Blue, Ken's Special, Butternut or Sweet Grey, Judge is to cut one in each sub section. (A total of 6 pumpkins are required).
30 points
- (b) Root Crops (beetroot, potatoes, onions etc.) – two types, 6 kg of each type.
30 points
- (c) Any other vegetable (tomatoes etc.) – two types, 6 kg of each type.
30 points

Sub-Section (vi) AGRICULTURAL PRODUCE

(Maximum 60 points)

Not eligible for entry elsewhere. At least 6 items, with a minimum of 1 item and a maximum of 3 items from any of 3 or 4 of the subsections (a), (b), (c) or (d). (10 points each). A minimum of 500g per item is required.

- (a) Nuts 2 types only (peanuts, macadamia nuts etc.) must be exhibited in the raw state mainly with shell on and a small sample of nuts (100grams) of each type displayed without shells.
- (b) Fibres - any natural plant or animal fibre in the raw/unprocessed state (raw cotton, sisal, hemp, flax, kenaf, greasy wool, mohair, cashmere, alpaca etc.)
- (c) Other products (including, Green Ginger, Coffee Beans, Navy Beans, and other pulse crops etc.)
- (d) Oil Seeds (Safflower, Black Sunflower, Soybean, Canola, Linseed, Linola, Sesame etc.)

Groups must supply Honorary Council Stewards with a list of items to be judged on Monday 5 August 2024.

Sub-Section (vii) COMMERCIAL TIMBERS

(Maximum 60 points)

Groups must display the items and quantities specified in any two of parts (a) (b) (c) (d) or (e). Minimum sizes of all timber samples to be not less than 250mm long x 90mm wide x 12mm thick. All timber samples from part A, B and C to be displayed in both the dressed and polished states.

One hardwood and one softwood are to be altered each year. Timbers not eligible for display in (a) (b) or (c) may be used to enhance the exhibit in part (e).

- (a) 3 varieties of Hardwoods (max 15 points)
1 point for each true sample 3 points
3 points for presentation of each sample (dressed and polished) 9 points
1 point for naming each sample correctly. 3 points
- (b) 3 varieties of Softwoods (max 15 points)
Only pine varieties are softwoods.
1 point for each true sample 3 points
3 points for presentation of each sample (dressed and polished) 9 points
1 point for naming each sample correctly. 3 points
- (c) 3 plantation timber varieties (excluding pine) or 3 cabinet timbers from this list (Silky Oak, Black Bean, Red Cedar, Silver Ash or Queensland Maple) or any combination of plantation timber and cabinet timber from above list.
1 point for each true sample 3 points
3 points for presentation of each sample (dressed and polished) 9 points
1 point for naming each sample correctly. 3 points
- (d) One student-built article of hardwood and/or softwood from one of the varieties displayed (10 points).
- (e) Presentation of timber samples as a part of the exhibit to make an effective display (20 points).

NOTE: Timber samples must be clearly and accurately labelled for judging showing standard trade name and botanical name or preceding name. Written information should also be supplied with the manufactured timber article.

Part (a) to (d) judged by Timber Judge on the Friday 9 August 2024. Timber samples may be provided to Stewards if group representative cannot be present for judging.
Part (e) judged by the Effective Arrangement Judge

Sub-Section (viii) OTHER PRODUCE

(Maximum 60 points)

2 of either (a), (b), (c), or (d).

- (a) **DAIRY PRODUCTS**
(Maximum 30 points)
Dummy or blank samples must be used on the display for milks, dairy desserts, yoghurts and cheeses. A duplicate of the displayed "blanks" must be presented for judging.
- (i) Milks: At least 600ml from any two of the following, Fat reduced milks; calcium enriched milks, skim milk, or flavored milk.
(5 points each – maximum of 10 points).
- (ii) Queensland made cheeses: May be boutique or specialty cheeses. A minimum of 100 grams of any 2 different cheeses (5 points each - maximum of 10 points)
- (iii) Any 2, with a maximum of 2 of any one of the following - dairy desserts/yoghurts/custards in a commercial container, minimum size 100 grams each.
(5 points for each - maximum of 10 points)

(b) POULTRY PRODUCTS

(Maximum 30 points)

One item from any two of the following groups (a), (b) or (c) (15 points each):

Standard Hen Eggs (1 dozen brown/off brown/dark)

Standard Hen Eggs (1 dozen white/off white/light)

One dozen from any other variety (duck, bantam etc.)

All hen eggs to be a minimum of 50g but not more than 61g in mass with the exception of item (c). One egg of each type to be broken by Judge for examination.

(c) APIARY PRODUCTS

(Maximum 30 points)

At least 500g of any 3 of (i) – (v):

- (i) Light honey 10 points
(ii) Dark honey 10 points
(iii) Block of white wax 10 points
(iv) Block of yellow wax 10 points
(v) Moulded wax may be used for display purposes only.

Honey must be shown in the Standard Trade Jar approved by the Queensland Beekeepers Association. The jar is round (not paneled) and of clear glass with white screw top. It measures approximately: Height 120mm with cap diameter 62mm and contains 500g reputed net weight of honey.

To expedite judging, jars should be filled to capacity. AN AIR SPACE OF 6mm IS TO BE LEFT AT THE TOP OF JAR.

(d) CURED MEATS

(Maximum 30 points)

- (i) Salamis, Mettwursts or Wursts – each of any 2 of these with total weight of 500 g (30 points)
OR
(ii) Cabanossi, Kabana – total weight of 500 g (30 points)

- Plus, five types of vegetables e.g.: Broccoli, Tomato, Potato, Sweet Potato, Butternut Pumpkins
- Exhibitors must also present four different types of produce incorporated into the display as it would look at a commercial level. See your supplier or onsite steward for more clarification.

Quantity required for judging:

- Small fruits and vegetables e.g.: apples, citrus, tomato, potato - 10 each
- Large fruits e.g.: pineapple, rockmelon, pumpkin etc. - 4 each
- Berries/nuts e.g.: macadamia, strawberries – 500g each

Judging will be performed by a panel of Judges appointed by the Royal National Agricultural and Industrial Association of Queensland.

No refunds will be made after close of entry. No refunds will be given for entries not presented or not adhering to the schedule regulations.

If COVID-19 recommendations and mandates advised by the Federal and State Governments mean the competition class you entered cannot proceed, the RNA will issue a full refund of your entry fee.

NOTICE TO INTENDING EXHIBITORS

Entries for the Royal Queensland Show can ONLY be made online through our [Exhibitor Portal](#). Entries submitted other than on the online portal will be returned to the Exhibitor and, unless all requirements are submitted online by 5.00pm on the Application to Enter closing date, as shown in the Schedule, they will not be considered.

As a condition for acceptance of all entries, all exhibitors/competitors agree to the following:

- All information submitted as part of my exhibitor profile is true and correct, including taxation status and bank account information.
- Neither myself nor my family members will indulge in any social, professional or other interaction with an official or judge contracted or sub- contracted by the RNA before or during the Royal Queensland Show.

PRIVACY STATEMENT

You can be assured that the privacy of your personal information is of the utmost importance to us. The information provided by you in any application for membership or application to enter is used by the Royal National Agricultural and Industrial Association of Queensland (RNA) to offer member services or to organize and conduct competitions at the Royal Queensland Show. By applying for membership or entering such competitions you consent to provide such details as your name, address and exhibit details. Competition information may be made available to the media and included in RNA publications.

The exhibitor irrevocably consents to the RNA publishing or reproducing in any manner whatsoever any particulars or information in relation to their exhibits; the publication or reproduction may be in a printed form or visual image through electronic means and/or on the internet. Your information will not be disclosed without your consent for any other purpose unless required by the law. PRIZE MONEY

1. Prize Money stated in the Schedule excludes GST.
2. All Prizes and Prize Monies are SUBJECT TO CHANGE at the discretion of the Competition Committee
3. GST will be added to the Prize Money for Exhibitors who are registered for GST purposes.
4. Prize money will be paid into your nominated bank account by 31 October following the Show.
5. The Association will provide a "Recipient Created Tax Invoice" to Exhibitors who are registered for GST purposes
6. All cash prizes and trophies must be claimed within six months from the closing date of the Royal Queensland Show. Prizes not claimed and by that date will be considered to have lapsed, and the amount will become a donation to the Association. (RNA By-Laws)

WORKPLACE HEALTH AND SAFETY

1. The Brisbane Showgrounds are a designated Workplace within the meaning of the Workplace Health and Safety Act 2011 and exhibitors/competitors are required to ensure that they and all persons under their direction or control, including their contractors or sub-contractors, comply with all requirements of the Act and the RNA holds each exhibitor responsible to discharge its obligations to provide and maintain a safe place and system of work during occupation by the exhibitor of any area of the Showgrounds.
2. Each exhibitor/competitor will assess the risk to themselves, staff, volunteers, family, other exhibitors, RNA staff, show visitors, children and any person foreseeably affected by the presentation of their exhibit.
3. Risks identified by exhibitors/competitors will be eliminated or controlled by the exhibitor/competitor and particular attention will be paid to ensuring public safety and safety of other exhibitors/competitors.
4. Exhibits will only be held and handled by competent persons whose experience is known to the exhibitor/competitor.
5. A "No Smoking Policy" will be strictly adhered to and policed by exhibitors/competitors and all are advised that the use of Primus stoves, any heating or lighting appliances of a like character, or any naked light, is strictly prohibited in the pavilions.
6. Any exhibitors/competitors intending to bring electrical equipment to the Showgrounds will be required to ensure that such equipment is fitted with residual current protection and that all electrical leads, tools and appliances have been inspected by a licensed electrical contractor and currently tagged. The use of double adaptors is prohibited, and all power boards must also be tested and tagged.
7. All exhibitors/competitors will comply with the requirements of the Act and its Regulations and Standards in every other respect. This is essential for the safety of all exhibitors/competitors and the general public. The Act imposes very severe penalties in the event of noncompliance with its provisions. Anyone who do not comply will not be allowed to exhibit at the Royal Queensland Show.
8. The Brisbane Showgrounds is subject to a Special Facility License issued under the Liquor Act 1992 and strict laws related to the consumption and possession of liquor across the Brisbane Showgrounds site. The consumption or possession of liquor outside of the licensed bar areas is not authorized by the RNA and in many cases may be an offence for which on the spot fines can be issued by Police and Liquor Licensing Investigators.

DISCIPLINARY COMMITTEE

132. It there is any inconsistency between By-laws 133 - 153 and any other By-laws of the Association, By-laws 133 - 153 will prevail.
133. The functions of the Disciplinary Committee shall be to hear and determine all complaints, allegations and other matters relating to:
- prohibited substances, as defined in these By-laws or Sectional Regulations.
 - any alleged breach of the Rules, By-Laws and Regulations of the Association by an exhibitor and relating to an exhibit or to a competition, except if the alleged breach is of a kind that the Chairman of a Sectional Committee considers is of a less serious nature and should properly be dealt with by the Sectional Committee, and
 - any other alleged breach of the Rules, By-Laws and Regulations of the Association that may be referred to Disciplinary Committee pursuant to By-Law 137 (a).
147. The Disciplinary Committee may announce its decision orally or in writing. A decision that is announced orally shall have effect in accordance with its terms.
148. If the opinion of the Disciplinary Committee is not unanimous, the decision of the majority shall prevail. If the Disciplinary Committee are equally divided on any question concerning the guilt or innocence of a person, the question shall be resolved in that person's favour.
149. If the Disciplinary Committee considers that there has been a breach of the rules, By-laws or regulations of the Association, it may impose such a penalty as it considers to be appropriate, including without limitation:
- a reprimand.
 - a monetary fine (payable at such time/s as the Disciplinary Committee may determine)
 - withdrawal or withholding of any award or ribbon.
 - disqualification in respect of any class.
 - expulsion from the Showground.
 - where the person concerned is a member, a suspension or termination of that membership.
 - a ban.
 - exclusion.
 - prohibiting a Person from exhibiting or competing at the current Show or at any future Show.
 - a direction that an Exhibit be removed from the Showground.
 - any other mandatory requirement; and
 - any other penalty provided for in other regulations of the Association.
150. There shall be no appeal from any decision of the Disciplinary Committee.

INSURANCE

161. The RNA may (but is not obliged to) take out a policy of insurance in respect of the legal liability on the part of an Exhibitor for loss or damage suffered by a third party caused by any act or omission of an Exhibit or the Exhibitor.
162. The RNA, RNA Staff Members and Officials of the RNA are not liable to any Exhibitor if the RNA fails to take out a policy of insurance effectively protecting any Exhibitor or Exhibit, or if any such policy does not operate to indemnify the Exhibitor in respect of the loss or damage in question.

REGULATIONS & BY-LAWS

All Entries and Exhibitors are subject to RNA Regulations and By-Laws set out in this schedule as well as other By-Laws that may pertain to this competition.

The RNA always reserves the right at its absolute discretion without assigning any reason to:

- substitute a Judge when necessary.
- re-allocate Judging days for a particular breed.
- if entries numbers require an extra Judge, appoint an additional Judge if necessary.
